This summer, Lake Greeley Camp will conduct four scuba diving clinics. Led by PADI (Professional Association of Diving Instructors) certified scuba diving professionals from Inland Water Sports, each clinic is approximately one hour in length. During that time, scuba instructors explain the basic principles of scuba diving and give an overview of the scuba gear. Instruction then moves into our Olympic-size swimming pool where each participant learns the basics of scuba skills. **Campers entering the 5th grade and older, who have passed the Deep Water Test and can demonstrate swimming skills equivalent to Level 3 as defined by the American Red Cross, are eligible to participate in this activity.** Space in each clinic is limited to 20 participants. Registration is on a first-come, first-served basis. The fee is \$25.00 per clinic.

### WAIVER AND RELEASE OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of permitting my child, \_\_\_\_\_ to enroll in a scuba diving instructional course and/or participate in scuba diving activities and related operations conducted by the Staff of Inland Water Sports through the facilities of Lake Greeley Camp in the County of Pike, and State of Pennsylvania during the month or months of July and August, 2017. I, for myself, my personal representatives, heirs and next of kin:

I hereby acknowledge that scuba diving is a potentially dangerous activity and involves the risk of serious injury and/or death and/or property damage. I further acknowledge that diving with compressed air involves certain risks and injuries that can occur which require treatment in a recompression chamber or other facility which may require a great distance of travel. I understand that the open water diving trips which are necessary for training and certification or for other diving activities may be conducted at a site that is remote, either by time or distance or both, from a recompression chamber or medical facilities.

I hereby release, waive, discharge and agree not to sue Inland Water Sports, Lake Greeley Camp, the dive leader or any of its officers, instructors, agents or employees (the Releasees) from all liability to myself, my personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands thereof on account of injury to my person or property or resulting in my death, now and forever, arising out of or related to participation and/or instruction in said course, activities or any other related diving operations that may occur, whether caused by the negligence of the Releasees or otherwise.

I hereby assume full responsibility for any risk of bodily injury, death or property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any related diving operations, whether foreseen or unforeseen and whether caused by the negligence of the Releasees or otherwise, I hereby separately agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost that they may incur, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any other related diving operations, whether caused by the negligence of the Releasees or otherwise.

I hereby acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of the Releasees and agree that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, including negligent rescue operations and is intended to be as broad and inclusive as permitted by the laws of the Province or State in which the activities are conducted and that if any portion thereof is held valid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I have read this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

As a parent or guardian, I am signing this document on behalf of my minor child and agree to be specifically bound to all of the terms and conditions of this Agreement. I have read the agreement, fully understand the terms therein, and understand that I have given up substantial rights by signing it. I am aware of its legal consequences, and have signed this document freely and voluntarily without any inducement, assurance or guarantee being made to me. I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and further agree to indemnify and save and hold harmless the Releasees. Additionally, I understand the risks of injury while scuba diving.
