CAR TRANSPORTATION INFORMATION

Whether you are driving your child to camp at the start of their camp session or picking them up at its end, arrival and departure days at camp can be hectic. Here are some guidelines and helpful tips that will make the day less stressful and more enjoyable.

ARRIVAL DAYS

Campers traveling to camp by car are requested to schedule their arrival between 10:00 a.m. and 11:00 a.m. Families traveling by car will be greeted by a Lake Greeley Camp staff member at the camp's driveway entrance. This staff member will have a roster of campers arriving by car and their cabin assignment. You will then be instructed as to our unpacking procedures and where you can temporarily park your car. Our counselors will be available to help carry your child's luggage to his or her cabin. Parents are welcome in their child's cabin to help them unpack.

Please note: Lake Greeley Camp is a smoke-free environment. While on the campgrounds, please refrain from smoking. In addition, no pets are allowed on the camp grounds. No exceptions can be made.

While you are at camp, please be sure to drop off any medication your child may be taking at the infirmary. Nurses will be present to discuss any medical concerns you may have. If you haven't already made your camper telephone call reservations, you can schedule them with our office staff. In addition, be sure to deposit spending money for your child in the camp bank. This money comes in handy on off-camp trips, and at the canteen.

Please keep your stay short. In order to keep as much order and organization as possible, we request that parents keep their stay short and not tour the camp grounds. Please plan to depart from camp before 12:30 p.m.

WHAT HAPPENS ON THE FIRST DAY AT CAMP?

- While the buses are arriving (between 11:30 a.m. and 2:00 p.m.), we will be serving the lunch meal. After campers unpack and get settled in, each cabin is given a tour of the camp. Returning campers commonly assist in leading the tours.
- In the early afternoon, a camper orientation will be held to introduce key staff members and review camp procedures and rules.
- Throughout the afternoon, all arriving campers accompanied by their counselors travel to the infirmary for an incoming medical check-in. Our nurses will check each camper's physical condition. This health screening is

primarily concerned with preventing a contagious condition from being brought into camp.

- A swim test is scheduled in order to evaluate each camper's ability to swim and provide for proper waterfront supervision.
- Our evening activity on arrival day is always a campfire, which is the camp's official welcome for our campers. It's a great way to end a very exciting day and start an awesome summer!

DEPARTURE DAYS

Departure days at camp are full of tears, the exchange of email addresses and fond farewells. While departure days are usually a sad occasion, they are nonetheless rather busy. In addition, on departure days other than the last day of camp, campers who remain in camp will be involved in scheduled activities and most of the staff will be scheduled instructional and supervisory responsibilities. For this reason, we request that parents keep their stay on the camp grounds as brief as possible.

Upon arrival at camp you will be greeted by a staff member who will record your child's departure from camp. (You do not need to report your child's departure at the camp office.) We will then instruct you to drive to a designated area, where you can temporarily park your car. Our counselors will help carry your child's luggage to your car.

Please schedule the pick-up of your child between 10:00 a.m. - 12:30 p.m. If you have made arrangements for another person to pick-up your child, Lake Greeley Camp must be notified in writing. A signed letter of authorization from the parent or guardian naming this person is required at least one week before the date of departure. A photocopy or faxed copy of this letter will not be accepted. Lake Greeley Camp will not release a camper into the care of any person under the age of 18 regardless of their relationship to the camper. In addition, the person picking up the camper must have at least one form of photo identification.
