

# Boat Tubing

Boat Tubing is a uniquely thrilling water sport that's like riding a roller coaster on the water. It's fast and exciting, and all you need do is to hang on and have fun. Towed by a motorboat, participants choose the speed that's right for them as they skim across the water. Campers are transported to nearby Lake Wallenpaupack where the activity is held. Experienced boat drivers and lifeguard supervision ensure safety procedures are followed and small group sizes (six campers or less) guarantee maximum tube time. Each Boat Tubing session includes approximately 3 hours of boat time. Space is limited and registration is on a first-come, first-served basis.

**Boat Tubing is open to all campers who have passed the Deep Water Test.** The cost is \$85.00 per session.

Due to lake conditions, inclement weather, and other factors that impact our time on the lake, **a maximum of one Boat Tubing session may be scheduled per week.**

Sessions cancelled because of inclement weather, or mechanical breakdown will be rescheduled or refunded.

### Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement

In consideration of permitting my child to participate in the boat tubing activity conducted by Lake Greeley Camp I, for myself and on behalf of my child, my personal representatives, heirs and next of kin do the following:

1. I understand that water sports in all its forms is an inherently dangerous activity and a bodily contact sport; and I knowingly and voluntarily assume all risks inherent thereto, including but not limited to the risk of drowning, of striking submerged, floating, or fixed objects including the lake bottom, shoreline, buoys and anchor lines, docks, reeds, debris of all types, the risk of striking or being struck by tow boats or other boats and associated equipment such as tubes and ropes, the risk of equipment failure, and all other unspecified risks. While safety procedures and personal discipline will minimize this risk, the risk of serious injury and/or death does exist.

2. I fully understand and acknowledge that: (a) risks and dangers exist in my child's participation in boat tubing; (b) my child's participation in boat tubing may result in injury, or damage to personal property, including the potential for permanent disability and death; (c) these risks and dangers may be caused by the boat operator, camp staff members or other participants, or by accidents, or by forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including but not limited to: the selection of the tubing area, weather conditions, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

3. I understand that the activity of boat tubing is physically and mentally intense. I have instructed my child in the importance of knowing and adhering by the rules, regulations and procedures established for the safety of boat tubing participants and other lake activity participants and my child has agreed to do so.

4. I hereby release, waive and discharge Lake Greeley Camp, its owners, directors, officers, employees and agents (the Releasees) from all liability to myself or my child, my personal representatives, all assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury and/or death to my child and/or property damage, now and forever, arising out of or related to participation and/

or instruction in said course, activities or any other related to boat tubing operations that may occur, whether caused by the negligence of the releasees or otherwise.

5. I hereby assume full responsibility for any risk of bodily injury, death or property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any related boat tubing operations, whether foreseen or unforeseen and whether caused by the negligence of the Releasees or otherwise. I hereby separately agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost that they may incur, now and forever, arising out of or related to my child's participation and/or instruction in said course, activities, or any other related boat tubing activity, whether caused by the negligence of the Releasees or otherwise.

6. I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

7. I have read this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me or my child and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

8. I hereby certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree not only to his/her release of Lake Greeley Camp and all other Releasees but also agree to release and indemnify the Releasees from any and all liabilities incident to his/her involvement in these programs for myself, my heirs, assigns, and next of kin.
